3. Deutschlandstipendium – note on data protection

Your personal data provided here will be treated confidentially and will be collected and processed exclusively for the purpose of selecting suitable applicants and for the implementation of the Deutschlandstipendium. The legal basis for this is §10 of the Scholarship Programme Act (StipG). According to this law, applicants for the scholarship programme are obliged to provide the information required to check the performance and aptitude requirements and to submit appropriate evidence. It is up to you which of these details you provide: tell us what qualifies you for a Deutschlandstipendium! We are aware that some of the information is highly confidential, some of the data (e.g. about diseases, migration background) are also so-called special categories of personal data in the sense of the data protection laws. Your data will always be treated confidentially and, together with our IT service provider, will be protected by up-to-date technical security measures.

If your application is not successful in this selection procedure, you can inform us that you wish to keep your application data for a maximum of another 12 months for another application in the next selection procedure. Otherwise, your data will be deleted immediately after completion of the award procedure.

Statistics/evaluation Anonymisation

According to §13 of the Scholarship Programme Act, we are obliged to transmit scholarship holder data to the Federal Statistical Office for the compilation of federal statistics. This is done under a pseudonym, i.e. without communicating your name.

Contact to the sponsor

Your sponsor might like to get to know you, to invite you to events or perhaps offer you an internship. However, this contact is only possible if you agree to the disclosure of your data to the sponsor. This is completely voluntary.
