

# Application Agreement

## Declaration of Participation – SRH University Heidelberg scholarship for gifted students in particular life situations

I hereby assure that I have taken note of the attached data protection information. In particular, it has been pointed out to me that I determine the extent of the personal data made available for the application for the SRH University Heidelberg scholarship for gifted students in particular life situations. I have noted that it is up to me to decide what information I provide for the application. Furthermore, I declare my consent that the personal data provided by me in accordance with §10 StipG may be processed by the SRH University Heidelberg for the purpose of selection for a SRH scholarship and, if applicable, for the purpose of awarding a SRH scholarship. I can revoke this consent at any time. If this consent is revoked, my data will be deleted immediately and the submitted documents will be destroyed in accordance with data protection laws.

Please note: In case of non-granting and as well as revocation of consent, the scholarship applied for shall not be granted, or shall no longer be granted.

### Note on data protection

Your personal data provided here will be treated confidentially and will be collected and processed exclusively for the purpose of selecting suitable applicants and for the implementation of the SRH scholarship. The legal basis for this is §10 of the Scholarship Programme Act (StipG). According to this law, applicants for the scholarship programme are obliged to provide the information required to check the performance and aptitude requirements and to submit appropriate evidence. It is up to you which of these details you provide: tell us what qualifies you for a SRH scholarship!

We are aware that some of the information is highly confidential, some of the data (e.g. about diseases, migration background) are also so-called special categories of personal data in the sense of the data protection laws. Your data will always be treated confidentially and, together with our IT service provider, will be protected by up-to-date technical security measures.

If your application is not successful in this selection procedure, your data will be deleted immediately after completion of the award procedure.
